

Predominantly of Georgian Revival architecture, the main body of the house features an elegant classic foyer with bridal staircase, traditional living and dining rooms, and a library with mahogany paneling. This section of the home has an expansive kitchen with a family dining area incorporating a stone fireplace. The family dining area is set in a bay and surrounded by windows overlooking the magnificent terraces and gardens. The garden level incorporates a recreation room with a bar, a home theatre and a fitness room. The Southern plantation-style east wing is dominated by the family room which has numerous French doors opening to a wraparound verandah. The upper level of this wing has a conservatory-style sunroom and a large deck, both private to the lavish master suite. The New England barn-style west wing comprises a 4-car heated garage and a full guest-suite on the second floor. The European-style rear pavilion contains a 37' swimming pool below a vaulted three-storey cathedral ceiling. Around the residence are multiple terraces and feature gardens, fieldstone walls, sweeping level lawns and an extensive selection of specimen plantings.
